



## **INSURANCE REQUIREMENTS**

All Exhibitors and Exhibitor Appointed Contractors are required to provide a valid Certificate of Liability Insurance via Fax (502.899.3952) or Email (insurance@truckingshow.com) a minimum of 30 days prior to the opening of the Mid-America Trucking Show. If a valid insurance certificate is not submitted, Exhibitor/EAC will not be allowed access to the exhibit floor.

### **Coverage Limits:**

The worker's compensation and employer's liability insurance must provide a minimum limit of \$100,000 and meet the requirements established by the State of Kentucky. Comprehensive general liability coverage must provide \$1,000,000 combined single limit bodily injury and property damage liability. Automobile liability should include all owned, non-owned, and hired vehicles with limits of \$1,000,000 combined single limit.

### **Policy Dates:**

Must include MATS Move-In, Event, and Move-Out Days

### **Additional Insured:**

Exhibit Management Associates, Inc., Kentucky Exposition Center & Genesis Exposition Services LLC must be named as additional insured.
